



JOINT COMMUNICATION Covenant Health/UNA PRC Forum Update – September 2024

Covenant Health and UNA PRC Forum representatives met on September 10th, 2024, as per Letter of Understanding #19 in the Covenant Health/UNA Collective Agreement. The purpose of the PRC Forum is to have good-faith discussions about improving the effectiveness of the Professional Responsibility Concern process.

The PRC Forum would like to share the following update from their latest meeting:

- Covenant Health and UNA recognize the need to update the Professional Responsibility Process (Best Practice) guide but have jointly agreed to pause revisions until Collective Bargaining between the parties has concluded.
- A new Professional Responsibility Concerns education CLIC module has been developed in collaboration with Covenant Health and UNA. It will soon be posted on the Covenant Health CompassionNet and UNA website for UNA members and management to access. Thank you to all who were involved in developing this important educational resource. - Covenant Health and UNA PRC Forum representatives have agreed to continue meeting three times a year. The next meeting will be in January 2025 in Edmonton.
