- AHS to provide its reply by end of the day, May 24, 2019.
- Parties to prepare written submissions to be supplied at the hearing and earlier if possible.
- The hearing is scheduled for May 31, 2019, commencing at 9:00 a.m.
- The Arbitrator is asked to file his record on or before the end of the day May 24, 2019.
- Chair of the Board is to decide if the panel is a three-member panel or the Chair sitting alone.

As a result, the hearing will take place on May 31, 2019, commencing 9:00 a.m. in the Pugh Room, located on the Fourth Floor at 10808 99 Avenue in Edmonton.
